## The highest standards within our field of business

Our aim to keep the highest standards within our field of business comes from our vision and mission, and it is part of our DNA. Our success relies on the confidence our stakeholders have in MFT Energy A/S and our subsidiaries (MFT Energy), and we play a critical role in building this trust. By envisioning to lead the future of energy trading, we make sure that MFT Energy can keep the highest standards within our field of business while trading energy efficiently and facilitating the green transition.

## Our Code of Conduct explained

All employees in MFT Energy are familiar with our Code of Conduct. We wish to guide our employees about expected behavior and decision-making, giving them the best conditions to behave according to our values and comply with relevant legislation. We want to ensure that our employees across our companies and cultures show the same behavior. Our Code of Conduct explains the principles for how we act as a company and the purpose is for it to prevent inappropriate behavior and protect the reputation of our company. Our Code of Conduct also give our counterparties an understanding of which values that guide our operations.

## Leaders walk the talk

With our Code of Conduct, the Leadership of MFT Energy sets the standards for how MFT Energy and its employees must behave, do business, and make decisions. This Code of Conduct applies to all employees at MFT Energy regardless of jurisdiction. It is the responsibility of all leaders in MFT Energy to ensure that the Code of Conduct is known and conformed to by all employees within their respective areas of responsibility by creating awareness and ensuring compliance. The leaders in MFT Energy also have the responsibility to act in a manner that sets a proper example.

## How we ensure a great working environment

#### + Against human trafficking and slavery

MFT Energy is against and does not tolerate human trafficking or human slavery in any form.

At MFT Energy, we promote equality, diversity and inclusion. We recognize that leveraging the strength of diverse teams and varied perspectives is particularly crucial in crafting innovative and impactful solutions. While our understanding of diversity goes beyond gender, achieving diversity in the energy trading industry has historically posed a challenge, given the industry's traditional male-dominated nature. Nevertheless, we are actively working to address the gender imbalance and eliminate all forms of discrimination by implementing policies for targets on gender balance.

To this end, MFT has implemented the following initiatives:

- Introducing gender balance targets for managerial positions and Board of Directors
- Launching recruitment initiatives, such as our anonymous application process, to ensure that our recruitment processes provide equal opportunities for both women and men.
- Providing bias training to leaders to raise awareness of biases in performance assessments, talent selection, and the appointment of management positions.

## + Respect and dignity

At MFT Energy, we make a great effort to ensure a non-discriminatory culture, where everyone is treated with respect and dignity, regardless of race, ethnicity, color, sex, sexual orientation, gender identity, disability, age, religion, political beliefs, national origin, social background, or any other grounds protected by Union regulations and national law.

### + A healthy working environment

At MFT Energy, we strive to ensure a healthy and safe working environment in line with fundamental human rights and labor rights.

This means that MFT Energy:

- Respects freedom of association and the right to Collective Bargaining
- Does not tolerate forced or compulsory labor, or child labor
- Promotes equal opportunities
- Does not tolerate any form of discrimination

## Integrity and transparency

Integrity is an important part of the core values of MFT Energy. To act with integrity means to do the right thing - also when no one is watching. Acting with integrity means that at MFT Energy the expectations to our employees are high. Our business is crucial to society and only by making a commitment to act with integrity are we able to build and maintain a culture where doing the right thing always comes first.

#### + Compliance within the field of business we operate within

MFT Energy operates on regulated markets. Due to this, we make a great effort in our work to comply with the rules and regulations governing these markets. At MFT Energy, the work of ensuring compliance is a continuous approach for preventing non-compliance such as market abuse and for meeting reporting requirements and license requirements. We ensure a high level of compliance through internal training as well as having policies and guidelines in place for all employees. We operate with integrity in our markets, and we do not engage in, or induce others to engage in, non-compliant business.

### + We respect privacy and IT security

We respect the privacy of our employees and counterparties. Protection of privacy and personal data is a fundamental human right, and we treat it accordingly. At MFT Energy, we process data about our employees and people whom we collaborate with. We process the data with absolute confidentiality and comply with the General Data Protection Regulation (GDPR) as well as national legislation.

Besides privacy and data protection, MFT Energy makes a great effort in relation to IT security. We work with IT security to minimize security breaches and their impact on our business. We follow high standards within this field and comply with applicable rules, legislation and best practices.

### + We manage sanction restrictions

We make a great effort to protect MFT Energy from being used to violate sanctions restrictions. We adhere to applicable international economic sanctions programs. We assess all our counterparties to ensure that they do not violate any restrictions that we cannot accept.

#### + Zero tolerance for corruption, bribery, and other forms of unethical business

We support and comply with legislation which regulates corruption, anti-bribery, and other forms of unethical business and will not tolerate such. As corruption threats the rule of law, democracy, human rights, fairness, and social justice, distorts competition, and manipulates the markets, our key values are based on high ethical and moral standards which are the core to our business. At MFT Energy, we prohibit all forms of bribery no matter whether they appear directly or through third parties and have implemented policies to ensure we do not become subject to bribery cases. It is the duty of MFT Energy and its employees to protect the public against fraud, misrepresentation, and unethical practices when MFT Energy is conducting its activities.

At MFT Energy we have zero tolerance for any form of financial crimes. At MFT Energy we have policies to ensure that we are not a subject for money laundering or terrorist financing.

### + We compete and operate in the market on fair and equal terms

MFT Energy supports a competitive market which allows us and our competitors to compete on equal terms. To ensure this, MFT Energy acts in compliance with competition laws and we expect our contractual partners to do the same.

#### + Conflicts of interests

We are committed to maintaining the highest standards of integrity, fairness, and transparency. We do not tolerate that personal interests compromise the interest of MFT Energy. Any potential conflict, such as outside business engagements, financial stakes in partner companies, or personal relationships that could influence professional decisions, must be disclosed.

#### + Our whistleblower scheme

We want to build and maintain a culture where all employees feel safe sharing ethical dilemmas and potential violations. Compliance with rules, legislation, ethics standards, and internal rules and guidelines matters to MFT Energy's success. We all have a responsibility to act ethical and to speak out if acts are not in accordance with our ethical guidelines, our employee handbook, and other governance documents. We have a whistleblower scheme that all employees have access to, to ensure anonymous raise of concerns.

## The green transition



At MFT Energy, we constantly work on minimizing our direct as well as indirect impact on the environment. We strive continuously to improve our work within the area of the environment and facilitating the green transition. We trade energy to make markets efficient by moving energy for it to be better utilized, which enables the green transition. Furthermore, we have added renewable products to our trading platform. We will further speed up our commitments to the green transition and invest in people and capabilities to scale up our environmental trading for us to support the green agenda and be sustainable in everything we do.
